

# How to handle rising energy and other costs

Tips to deal with price increases in your everyday essentials

#### **Gas and Electricity**

The cost of energy has increased substantially. From 1 October 2022, there's a limit on gas and electricity prices for most households. <b>Now available for Camden residents facing severe financial hardship:</b> Camden Council Cost of Living Crisis Fund for Camden residents and families facing severe financial hardship and who cannot afford essentials – including food, energy bills, water, electricity and housing. If you <b>can't afford to top up your prepayment meter</b> you can get temporary credit and, in some circumstances, additional support credit. Your supplier might add this to your meter automatically when you run out of credit, or you might have to contact them and ask. If you're <b>struggling to pay your energy bill</b> you may be able to get help with this-see above and <u>here</u> for information. If your <b>supplier increases your direct debit</b> you may be able to challenge this. Information <u>here</u> .

## Maximise your income

	Check that you are claiming all the <b>benefits</b> that you are entitled to on <u>our website here</u> or <u>Turn to Us here.</u>	
	If working and health/childcare permits – can you increase working hours? Find out what your <b>take home pay</b> could be <u>here</u> and check benefit amount <u>here</u> .	
	You can check the <u>Check the National Minimum Wage calculator</u> to see if you are being <b>paid the right amount</b> .	
	You can check if your tax code is correct and any possible <b>refund or allowances</b> <u>here.</u>	
	If you are a single parent you can check if you can get some <b>Child Maintenance</b> here.	
	You might be able to ask other people living or staying with you for <b>contributions to rent/mortgage</b> . If you have an extra bedroom you could consider <u>finding a lodger</u> .	
Housing and Council Tax		
	Are you able to reduce your <b>council tax</b> bill through discounts or exemptions? Check <u>here.</u>	
	Can you cut your <b>mortgage</b> costs? There is information <u>here on our website</u>	
	Can you reduce your <b>rent</b> costs? Do you need a <b>Discretionary Housing Payment</b> ? There is more <u>information about this here</u> and <u>here.</u>	
	Food	
	If you need food you can find a food bank close to you <u>here</u> and find other food-giving organisations <u>here</u> .	
	Check <u>here</u> for tips on cutting the cost of food shopping and planning meals on a budget.	
	Water	
	Check the <u>Consumer Council for Water website</u> to see if you'd save money by changing to a water meter and see <u>our website here</u> and <u>here</u> for other ways of <b>reducing your water costs.</b>	

### Landline, TV, Internet and Mobiles

Can you <b>switch</b> your telephone, TV, internet or mobile provider for a better deal? See <u>information here</u> on what to think about before changing your provider.
You may be eligible for cheaper <b>social tariffs</b> for your broadband and telephone line. You can check &lt;u&gt;here.&lt;/u&gt;&lt;/td&gt;&lt;/tr&gt;&lt;tr&gt;&lt;td&gt;You may be able to get &lt;b&gt;Healthy Start Vouchers&lt;/b&gt; if you are pregnant and/or have children 4 years or younger. Check here.&lt;/td&gt;&lt;/tr&gt;&lt;tr&gt;&lt;td&gt;&lt;b&gt;Free school meals&lt;/b&gt; for all Year 1 &amp; 2 in Camden. For Year 3 or above if you are on means tested benefits (dependent on your income). See &lt;a href=" https:="">here.</a>
Travel
Are you eligible for <b>discounts</b> on <b>TfL</b> public transport? Eg over 60, Disabled, Student, Apprentice, Jobseeker. Information <u>here</u> .
If you have a disability you may be able to <b>reduce travel and parking</b> costs. See <u>here.</u>
